**RENEWAL OF AGRICULTURAL REMEDY REGISTRATION**

Kindly note that some of your agricultural remedies registration(s) is/are valid until **31 May 2025**.

With reference to the **2025/2028** registration cycle, please note the following:

**1. RENEWAL: FORM A**

- a) Form A must be completed in triplicate.
- b) A service request form
- c) Original Letter of supplier of technical material not older than twelve months (12)
- d) Each product that is to be renewed must be depicted on Form A.
- e) Please enclose copies of the previous cycle certificate.

**2. OTHER FORMS TO BE SUBMITTED**

**Form B** must be completed in duplicate in respect of the agricultural remedy of which the registration shall not be renewed. The original registration certificate of the product to be cancelled, must be returned to the Registrar's office for record purposes.

Should the original registration documents be lost, a sworn declaration to this effect must accompany the renewal form.

**Forms C and D** must be completed in duplicate and returned.

### 3. APPLICATION FEE

The prescribed application fee of **R6 804.00** must be payable to the Director-General: Department of Agriculture, Land Reform & Rural Development by Electronic Payment. Electronic payment details are as follows:

The application for renewal, either by courier or hand delivered must reach the Registrar's Office not later than **31 May 2025**.

### 4. LATE RENEWAL APPLICATIONS

The renewal application submitted as from 1 June 2023 is considered late renewal application and must be accompanied by additional late application fee of **R4 750.00** bringing the total amount to **R11 554.00** per product.

Application for renewal received after **30 June 2025** is considered as lapsed registration. It must be noted that an Agricultural Remedy that was previously registered, lapsed and never renewed such product is no longer valid and section 4A of the Fertilizer Farm Feeds, Agricultural Remedies and Stock Remedies Act 36 of 1947 shall apply.

### 5. CONDITIONS FOR RENEWAL

- **The daughter registration must be accompanied by the recent signed daughter agreement.**
- The formulation of the agricultural remedy concerned does not deviate from the existing formulation as registered,
- The particular and wording approved for a label or container used in connection with the sale of the agricultural remedy concerned, has not been altered without the prior written approval of the Registrar,
- The registration concerned shall not be in any manner or circumstances be transferable,
- The source of active ingredient(s) has not been changed,
- The immediate container and pack sizes shall not be altered without prior approval from the Registrar,

- An affidavit to confirm that the sources of active ingredient(s), formulation and the label have not been changed.
