**RE: ANNOUNCEMENT OF NEW PLANT HEALTH TARIFFS FOR THE IMPORTATION
OF PLANTS AND PLANT PRODUCTS INTO THE REPUBLIC OF SOUTH AFRICA WITH
EFFECT FROM 01 APRIL 2025**

As of 1 April 2025, import permits issued in terms of the Agricultural Pests Act, 1983 (Act No. 36 of 1983) for controlled/ regulated goods of plants, plant products and associated products, such as live or dead parts of a plant or derivation thereof, pathogen, insect, exotic animal, growth medium, infectious thing, honey, beeswax, or used apiary equipment) in terms of the above Act, will be issued at a new tariff as follows:

Item	Tariff
1. Issuance of an import permit	R240
2. Issuance of an amendment letter	R410
3. Issuance of a copy of an import permit	R240
