ANIMAL DISEASES REGULATIONS.—AMENDMENT

The Deputy Minister of Agriculture, acting on behalf of the Minister of Agriculture under section 31 of the Animal Diseases Act, 1984 (Act 35 of 1984), has made the regulations in the Schedule.

SCHEDULE

Amendment of Table 2 of the Regulations

1. Table 2 of the Animal Diseases Regulations published by Government Notice R. 2026 of 26 September 1986, is hereby amended with effect from 2 March 1987 by the insertion of the particulars in the Table hereto after the animal disease "Equine infectious anaemia."
