Introduction to International Trade

- International trade is regulated by the World Trade Organisation (WTO).
- Agreement on Agriculture & SPS Agreement
- Agricultural trade plays a crucial role in delivering food to consumers
- worldwide.
- Provides greater choice in consumer goods, and has played a role in
- Reducing food insecurity across the globe.



International Market Dynamics

- Prospects of (overcoming) barriers & protectionism
- Trade wars are changing global trade flows
- Disease outbreaks remain a food security threat
- Price volatility effects & changing consumer preferences over time
- High transaction costs (e.g. costly harbours, payments) and ad hoc policy application (noncompliance to agreements)

•AFRICA - SACU – 1969 (Established in 1910. Last amended in 2002)

- SADC FTA – Signed 1996 (entered into force in year 2000)

- COMESA-EAC-SADC T-FTA (signed since 2015. About 9 countries have ratified it. Not yet implemented)

- AfCFTA (signed by 54 countries since 2018. About 36 Member States have ratified it. ٠ Implemented from January 2021. Some Rules of Origin & tariff negotiations are still outstanding and should all be completed latest by June 2021)
- •EUROPE SADC-EU EPA (Implemented from 2016, replacing trade aspects from TDCA implemented in 2000)
 - SACU-EFTA FTA (Implemented from 2008. The Agreement is currently under review)
 - SACUM–UK EPA Implemented from 1 January 2021

•AMERICA - USA's AGOA

- SACU-MERCUSOR PTA (implemented from 2016)

•ASIA - None

•MULTILATERAL - WTO Agreement on Agriculture

Trade Agreements currently being negotiated/reviewed

- COMESA-EAC-SADC T-FTA Negotiations Ongoing (SA signed).
- African Continental Free Trade Agreement (ACFTA) Negotiations ongoing to conclude on outstanding matters during 2021 (SA signed & ratified). The Agreement was implemented from January 2021 and is now gazetted & reflected in the SACU tariff book. Trade will commence when outstanding issues are concluded latest by June 2021.
- SACU-EFTA Free Trade Agreement The review of the existing Agreement is under way
- SACU-INDIA Preferential Trade Agreement put on hold due to lack of ambission
