## NOTIFICATION

Addendum

The following communication, received on 10 May 2023, is being circulated at the request of the Delegation of <u>Canada</u>.

Established Maximum Residue Limits: Fluazinam

The proposed maximum residue limit (PMRL) document for fluazinam notified in G/SPS/N/CAN/1476 (dated 6 February 2023) was adopted 3 May 2023. The proposed MRLs were established via entry into the Maximum Residue Limits Database and are provided directly below:

<u>MRL (ppm)<sup>1</sup></u> Raw Agricultural Commodity (RAC) and/or Processed Commodity

0.07 Cucurbit vegetables (crop group 9)<sup>2</sup>

<sup>2</sup> A crop group MRL for cucurbit vegetables (crop group 9) is now established, while the MRLs of 0.07 ppm for individual commodities within crop subgroup 9A are expired.
