5. Title of the notified document: Proposed Maximum Residue Limit: Chloropicrin (PMRL2023-31). Language(s): English and French. Number of pages: 7
6. Description of content: The objective of the notified document PMRL2023-31 is to consult on the listed maximum residue limit (MRL) for chloropicrin that has been proposed by Health Canada's Pest Management Regulatory Agency (PMRA). <u>MRL (ppm)¹ Raw Agricultural Commodity (RAC) and/or Processed Commodity</u> 0.025 Stalk, stem, and leaf petioles (crop group 22) ² ¹ ppm = parts per million ² The MRL is proposed to replace the currently established MRLs of 0.025 ppm in/on asparagus, cardoon, celery, celtuce, Chinese celery, fresh Florence fennel leaves and stalks, kohlrabies and rhubarb with a single crop group 22 MRL. This will result in a single MRL that will be applicable to all commodities within crop group 22.
