The application was submitted for the reauthorization of this substance in accordance with article 10 of Regulation (EC) No 1831/2003. Further to the positive assessment by the European Food Safety Authority, this substance is reauthorized as feed additive for all animal species, under certain conditions. A transitional period is included for the interested parties to meet the new authorization's requirements.
