# REGULATIONS REGARDING DEPARTMENTAL FEES: AMENDMENT

The Minister for Agriculture, Land Reform and Rural Development has, under section 15 of the Agricultural Product Standards Act, 1990 (Act No. 119 of 1990) -

- (a) made the regulations in the Schedule; and
- (b) determined that the said regulations shall come into operation on 1 April 2024.

#### SCHEDULE

#### Definition

1. In this Schedule "the Regulations" means the Regulations published by Government Notice No. R. 1259 of 27 September 2019, as amended by Government Notices Nos. R. 179 of 21 February 2020, R. 359 of 23 April 2021, R. 1918 of 25 March 2022 and R. 2956 of 27 January 2023.
