AMENDMENT OF DISPENSATION: PERMISSION TO USE "MIXED PORTIONS" AND "BRAAI PACK" AS CLASS DESIGNATIONS ON THE LABEL

- 1. It has come to the Department's attention that the indication "Braai cuts" is also used to describe mixed chicken portions.
- **1**. This office's fax (Ref No. 20.4.11.1.2/Poultry Meat) dated 12 December 2011 with the heading "Dispensation: Permission to use 'Mixed portions' and 'Braai pack' as class designation on the label" (see attached) is hereby amended by substituting point 3 with the following:

"In view of the aforementioned, permission is hereby granted by the Executive Officer: Agricultural Product Standards in terms of section 3(1)(c) of the Agricultural Product Standards Act, 1990 (Act No. 119 of 1990) to the poultry meat industry to use 'Mixed Portions', 'Braai Pack' and/or 'Braai Cuts' as class designation on a container of poultry meat containing several combinations of thighs, drumsticks, wings, breasts and backs"

DISPENSATION: PERMISSION TO USE "MIXED PORTIONS" AND "BRAAI PACK" AS CLASS DESIGNATIONS ON THE LABEL.

- The regulations relating to poultry meat (published by Government Notice No. R. 946 of 7 March 1992, as amended) prescribe that the class designation that is marked on the container or wrapper of poultry meat, shall be the applicable class designation or alternate class designation specified in columns 2 or 3 of Table 1 and no class designation other than the applicable class designation or the alternative class designation shall be marked on the container of a poultry carcass or of a single type portion pack.
- 2. Directorate: Inspection Services has indicated to this office that there is a national use "Mixed Portions" and Braaipack" in the industry, and we also received comments and requests from the industry to use the words as class designations.
- 3. In view of the aforementioned, permission is hereby granted by the Executive Officer: Agricultural Product Standards in terms of section 3(1)(c) of the Agricultural Product Standards Act, 1990 (Act No. 119 of 1990) to the poultry meat industry to use "Mixed Portions "and/or "Braai Pack" to label and use as class designation on a container of poultry meat containing several combinations of thighs, drumsticks, wings, breasts and back.

This permission is subject to the following conditions:

- (a) All other conditions of the local regulations shall be complied with and new labels should be sent to the Department for assistance in this regard.
- (b) It may be withdrawn at any time should a valid complaint be received.
- (c) The poultry meat industry indemnifies this Directorate and the Department from any detrimental effect, financially or otherwise, which may emanate as a result of this permission.
