## DISPENSATION: COUNTRY OF ORIGIN INDICATION ON PACKAGING CONTAINING ANIMAL & PROCESSED PLANT PRODUCTS REGULATED UNDER THE APS ACT

## 1. Background

Marking requirements pertaining to the country of origin indication on packaging containing animal and processed plant products intended for sale on the local RSA market and regulated in terms of the Agricultural products Standards Act, 1990 (Act No. 119 of 1990) are ---

- (a) in some instances not very specific and do not provide clear guidelines to inspectors (just state "country of origin");
- (b) in some instances very prescriptive and restrictive (only allow for the use of the expression "Product of" or "Imported from" or "Manufactured in"); and
- (c) not in line with the latest labelling and advertising of foodstuffs regulations (R.146 of 1 March 2010) of the Department of Health which came into effect on 1 March 2012.

In view of the above-mentioned shortcomings, the following dispensation is therefore issued to provide for the use of the country of origin indication in accordance with regulation R.146 of 01/03/2010. Please take note that in the case of certain products the dispensation will only be applicable to imported products (which is in line with the existing requirements in those specific regulations) since extending it to include local products as well will make the regulations more strict which defies the purpose of a dispensation.

## 2. Repealing of a previously issued dispensation

The following dispensation issued on 9 March 2012 is hereby repealed:

"Industry dispensation: Country of origin indication on Vinegars - Indication & letter size"

## 3. Dispensation

Permission is hereby granted by the Executive Officer: Agricultural Product Standards in terms of section 3(1)(c) of the Agricultural Product Standards Act, 1990 (Act No. 119 of 1990), to all manufacturers, packers, retailers and importers of the animal and processed plant products listed in the Annexure hereto, to indicate the country of origin as follows on all packaging (containers and outer containers) containing these products: Provided that no abbreviations shall be used and the letter size of the smallest letter in such indication shall be at least 1mm in height

- (a) "Product of (name of country)" if all the main ingredients, processing and labour used to make the product are from one specific country; or
- (b) "Produced in (name of country)", "Processed in (name of country)", "Manufactured in (name of country)", "Made in (name of country)", or wording having a similar meaning, when the product is processed in a second country which changes its nature:

Provided that the words "Packed in (name of country)" may be used in addition to the requirements of paragraph (a) or (b) above.

This permission is subject to the following conditions:

- (a) All other conditions of the relevant regulations shall be complied with.
- (b) It may be withdrawn at any time should a valid complaint be received.
- (c) All manufacturers, packers, retailers and importers of the animal and processed plant products listed in the Annexure hereto, indemnify this Directorate and this Department from any detrimental effect, financially or otherwise, which may emanate as a result of this permission.
- (d) Termination date: When the amendments of the relevant regulations are published in the Government Gazette.
