APPLICATION FOR AUTHORISATION TO USE IMPORTED GMO'S AS FOOD, FEED OR FOR PROCESSING IN SOUTH AFRICA

Directions to the applicant:

- This application form is for use by an entity (a miller) who will be responsible for milling the consignment before it may be used or sold to be used as, obtained from a trader or agent, as food, feed or for processing.
- The consignment must be milled as soon as it is received from the importer or its agent.
- The consignment may NOT be used for planting purposes in SA.
- Please take note that the purchased consignment may only be transported in ONE trip to the user's premises for milling, i.e. movement of the consignment in SA prior to milling must be reduced to one trip only.
- Please complete all sections of the questionnaire provided below. Please provide reasons if a particular section of this form is not completed ("not applicable" will not be accepted – one must provide reasons why a particular question is not applicable).
- Please provide one copy of the application with confidential information for use by the regulatory bodies appointed in terms of the Genetically Modified Organisms Act, 1997 (Act no. 15 of 1997). This copy must be clearly marked: CONFIDENTIAL
- Please provide one hard and an electronic copy of the application containing no confidential information. This copy must be clearly marked: NON-CONFIDENTIAL, and may be made available for public scrutiny.
- The application must be accompanied by the prescribed fee (see www.daff.gov.za)
