1. INTRODUCTION¹

Belarus, together with Russia and Kazakhstan are members of a Customs Union. Countries in a Customs Union are required to maintain a common external tariff (CET) against third countries. The accession of Russia to the WTO has been confirmed; this will inevitably lead to a reduction of the customs duties of the other countries in the Customs Union. Therefore, this will lead to better market access for other countries to these markets. When Belarus and Kazakhstan become WTO members, market access may increase even more.

Table 9 indicates that export of Agriculture/Fisheries/Forestry products by SA to Belarus was less than R400 000 in 2011. During the period under discussion there were no fisheries exports by SA to Belarus and in 2010 the exports of forestry products were less than R11 000. In 2009 and 2011 there were no exports of forestry products to Belarus by SA. In 2011, buttermilk, fresh or chilled onions, fresh oranges, yoghurt and milk and cream were the most agricultural products exported to Belarus
