### 2. Economic overview of Georgia<sup>2 3</sup>

Georgia is characterized by a lower-middle-income economy.

The war in August 2008 with Russia caused substantial damage to infrastructure, as well as an influx of several thousand internally displaced persons (IDPs) from the conflict areas. Public funds, supplemented by a large amount of foreign aid, are being used to provide humanitarian assistance to IDPs, and to rebuild military and civilian infrastructure.

Real GDP expanded by 7% in 2011. This represented a continuing strong pick-up, following the negative impact of the global economic recession of 2009, which came in the wake of the war in 2008. In early February 2013 Georgian and Russian officials confirmed that Russia planned to resume imports of Georgian wine and mineral water over the next few months. It is thus expected that relations between the two countries is busy improving.

### 3. Agricultural production in Georgia<sup>4</sup>

Following post-independence turmoil, domestic food production experienced a severe decline. Agriculture has performed erratically in recent years. The estimated share of agriculture's GDP has fallen to around 11% in 2006 from 35% in the mid-1990s. In 2010 the agricultural sector, which typically accounts for around 10% of total GDP, performed poorly, contracting by 1.7%. The performance of the agricultural sector, which remains primarily subsistence based, was hindered by poor weather conditions, including floods and hail at the start of the year and then by drought during the harvesting season. The presence of subsistence farming makes it more difficult for Georgian farmers to compete effectively on global financial markets.

In an address to the Ministry of Agriculture on 8<sup>th</sup> March 2011, the president called for the direct interference of the state in the agricultural sector. The president pledged that Georgia's agricultural sector would be transformed into a sector befitting the 21st century within 12-18 months.

Agriculture as origin of GDP was 11% in 2011. A contraction in year-on-year output was recorded in agriculture (-4.4%, 2012 vs 2011). The agricultural outturn for the year is expected to be much weaker than the 5.5% expansion recorded in 2011. Hailstorms in July and August caused considerable damage to a range of crops, including fruit, vineyards and corn.
