#### 2. QATAR'S ECONOMY<sup>2</sup>

The GDP at market exchange rate was US\$194.4 billion in 2012, with a real growth rate of 5.8%. Estimated consumer inflation was 1.9% in 2012. The budget surplus is estimated at 8.3% of GDP in 2012/13 and is expected to stay on average at 4% for the period up to 2016/17. The GDP per head (US \$ at market exchange rate) is estimated at \$105 824 in 2012, that is one of the highest GDP per capita rates for a country in the world. Table 1 indicates the major exports and imports of Qatar in 2011.

#### 4. QATAR'S IMPORTS FROM THE WORLD <sup>4</sup>

Table 2 indicates the top 30 imports of agricultural, forestry and fisheries products by Qatar from the world. It is noted that lumber; doors & frames; books, brochures & leaflets are the only forestry products amongst the top 30 imports from the world. No fishery products are represented under the top 30 imports from the world.

#### 5. SOUTH AFRICA'S TRADE WITH QATAR <sup>5</sup>

#### 5.1 Trade Balance for all products traded between SA and Qatar

Table 3 indicates that for the period 2010 to 2012, SA had a trade deficit for trade in all products with Qatar. Major products that Qatar has exported to SA are: mineral fuel, fertilizer and aluminium.

#### 5.2 Trade Balance for agricultural, forestry and fisheries products traded between SA and Qatar

Table 4 indicates that for the period 2010 to 2012, SA had a trade surplus in agricultural, forestry and fisheries products traded with Qatar. During this period the imports of agricultural, forestry and fisheries products by SA from Qatar were less than R600 000 a year.
