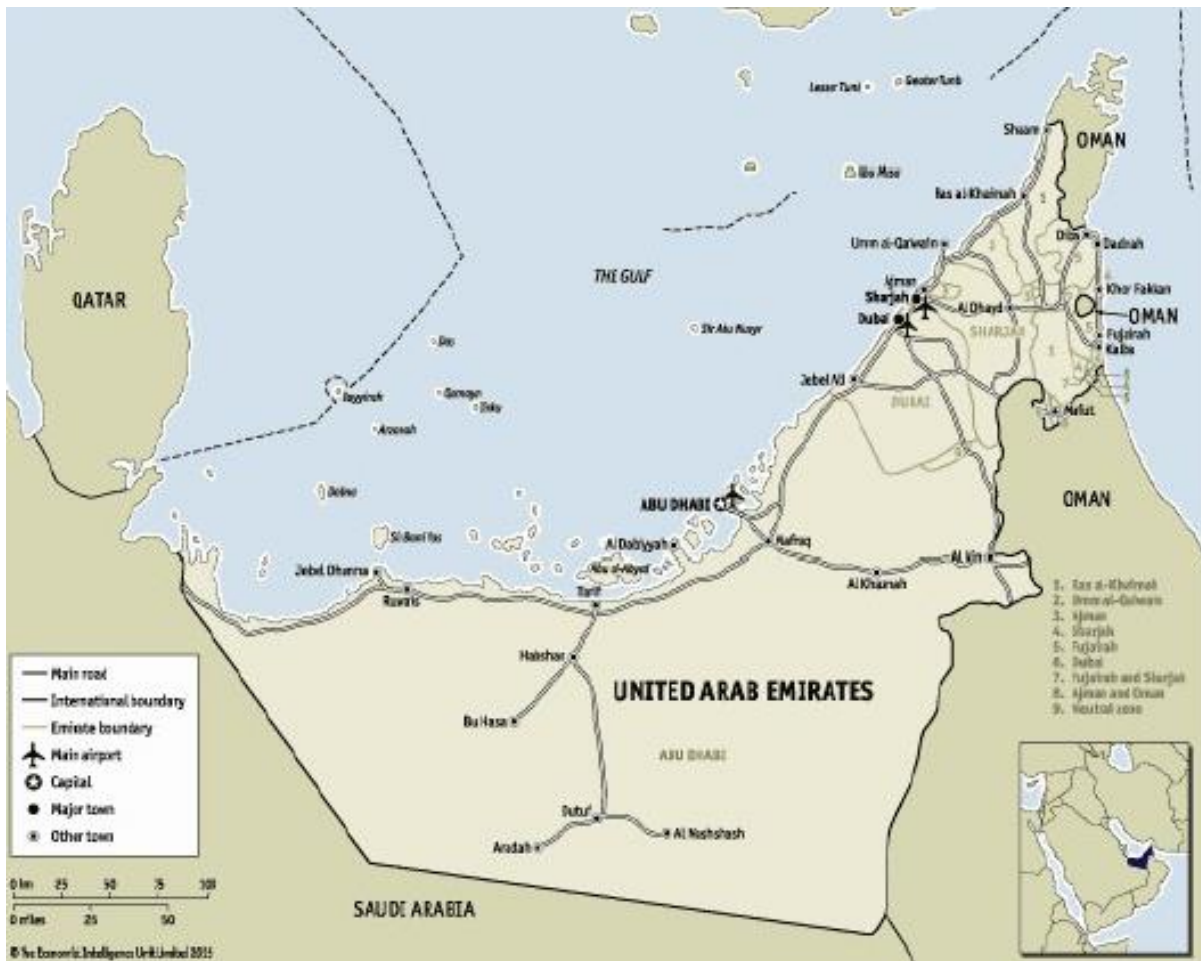

1. INTRODUCTION

The primary objective of this study is to identify which products may have the potential to be exported by South Africa (SA) to the United Arab Emirates (UAE). The secondary objective is to get an understanding of the UAE environment, with a focus on trade.

2. COUNTRY FACTS²

Land Area: 77 700 km² excluding islands

Climate: 97% is desert. The bulk of the population is living in the coastal areas – summer (May – Oct) temperature up to 46 °C and humidity up to 100%. Winter (December to March) - temperatures between 14 °C and 23 °C. Interior desert climate with cool winters and hot arid summers

Population: 7.9 million (2013 EIU estimates)

Member States (% of population in each emirate – 2011: EIU estimates)

Abu Dhabi: 39%

Dubai: 29%

Sharjah: 18%

Other emirates: 14%

Time: 4 hours ahead of GMT

Capital: Abu Dhabi City

Language: Arabic, English widely understood. Hindi and Urdu are common among immigrants

Type of Government: federation with specified powers delegated to the UAE federal government and other powers reserved to member emirates

Level of Economic Development: Developing Country

Currency: UAE dirham (pegged to the US \$ - US \$ 1 = Dh3.67)

3. HISTORICAL BACKGROUND³

The UAE is a federation of seven states that came into existence in December 1971, the day before Britain ended its treaty relationships in the Gulf. The seven emirates that make up the UAE are: Abu Dhabi, Dubai, Sharjah, Ras al-Khaimah, Ajman, Umm al-Qaiwain and Fujairah.

Before the oil boom in the early 70^{ties} the UAE was a collection of coastal and desert settlements, dependent on meagre trade, pearling and subsistence farming. The coastal towns have been serving as trading ports for hundreds of years and are well located for transshipment from India, Africa and Iran.

The two major emirates are Abu Dhabi and Dubai. Abu Dhabi is the emirate with the largest land area and is the most affluent Emirate. Its share of the oil wealth is more than 90%. Dubai is the commercial and shipping hub of the country and have created premier port and airport facilities, ICT, tourism, warehousing and financial infrastructure. The UAE see itself as the regional financial centre and a hub for trade, transport and tourism that is vital for growth and economic diversification. The UAE plans to launch the second phase of the national rail program and expand other transport, port and energy infrastructure.

4. ECONOMIC OVERVIEW^{4 5}

The UAE authorities tried to reduce its dependency on oil exports, by diversifying the economy, creating booming business, tourism and construction industries. The oil industry has attracted a large influx of foreign workers, who together with expatriates make up more than three quarters of the population.

The UAE had a current account surplus of 15% of GDP in 2014. Inflation was 2.3% in the UAE in 2014, but has increased to an average of 4% for the first five months in 2015. The UAE dirham is pegged to the US \$ (US \$ 1 = Dh3.67). Table 1 indicate some economic indicators for the UAE.

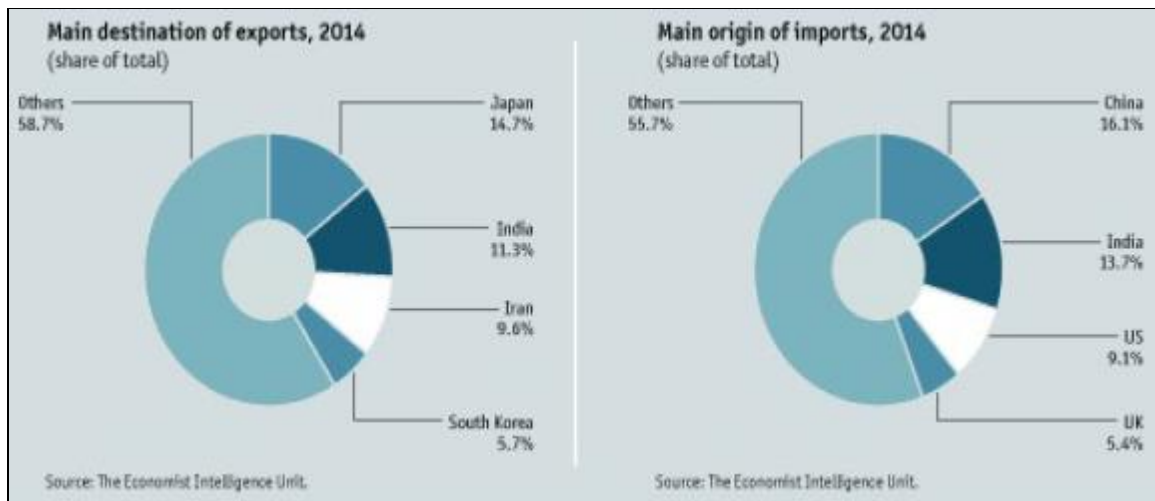


Figure 1: Main destination/origin of exports/imports in 2014

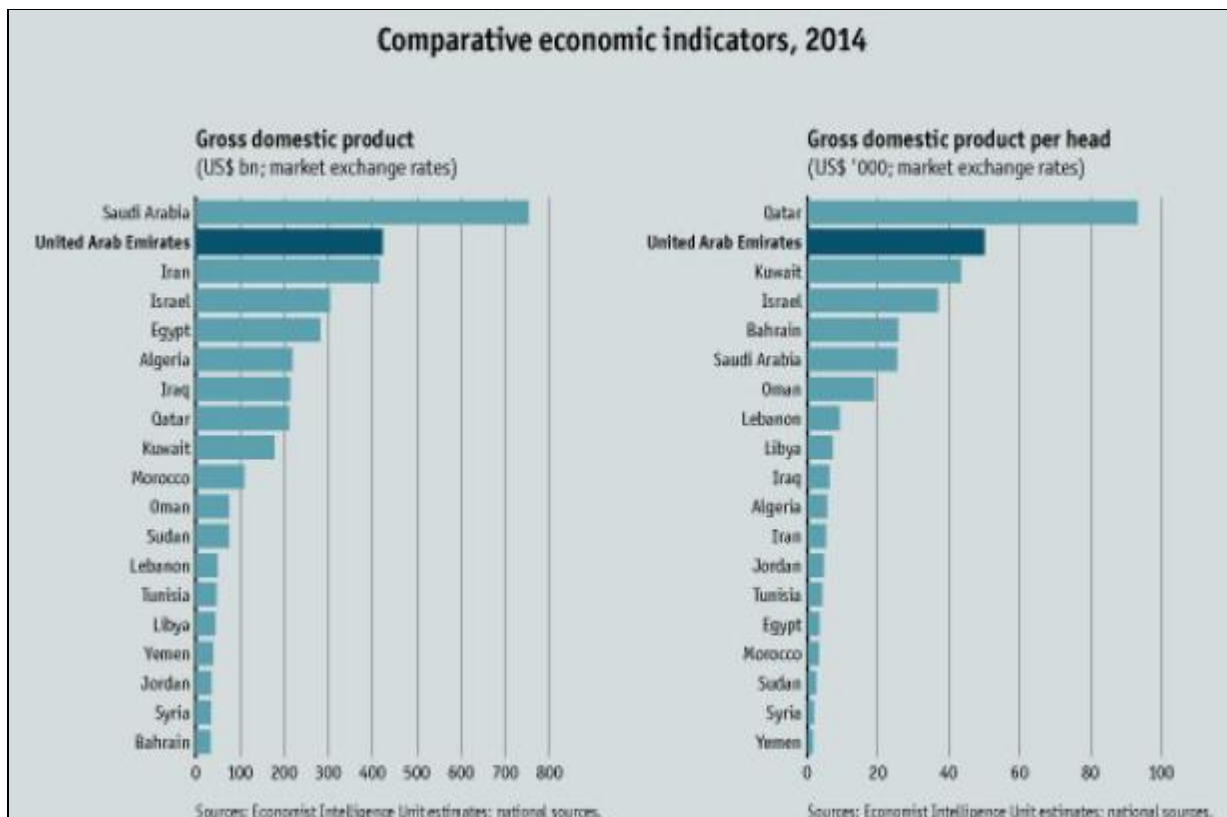


Figure 2: Comparative GDP and GDP per head in and around the UAE

Figure 2 compare the GDP and GDP per head of comparative countries to the UAE.

5. INFRASTRUCTURE⁷

The infrastructure of the UAE is well developed. Dubai generates sizeable revenue from re-exports and invests heavily in infrastructure. The other emirates, especially Abu Dhabi follows Dubai's example to invest heavily in infrastructural projects.⁸ The oil price slumps in 2015/16 will reduce the current account surplus substantially.⁹

The Global Enabling Trade Report of 2014 of the World Economic Forum has rated the infrastructure of the UAE as indicated in table 4:

6. RISK PROFILE¹⁰

Table 5 indicates the risk profile of the UAE. The definition of each type of risk is given in annex 1.

Sovereign risk

This risk category is ranked as BBB. The UAE has made progress in debt restructuring, since the debt standstill of Dubai in 2009. Nevertheless the lower expected oil price in 2015/16 is negative for economic growth, fiscal revenue and export revenue.

Currency risk

The UAE Dirham will stay pegged to the US \$. The lower expected oil price will however reduce the previously large current account surplus in 2015/16.

Banking sector risk

The banking sector profits has picked up in recent years, with slower growth in the provisioning for non performing loans and an increase in loan growth.

Political risk

The UAE is expected to remain politically stable in 2015-16. However the UAE's location in the Middle East presents some geopolitical risk in its self.

Economic structure risk

The UAE openness makes it vulnerable to external shocks, and although it is more diversified as other countries in the region, it will still be vulnerable to fluctuations in oil and gas prices.

Country risk

The overall country risk is a score of a BBB.

7. BILATERAL, REGIONAL & MULTILATERAL AGREEMENTS^{12 13}

The UAE regards free trade as important to increase competitiveness and have a relative open economy.

The UAE have signed bilateral preferential agreements with some Arab countries. According to these agreements, the UAE and its partners accord each other preferential access for a list of products.

The UAE is a founding member of the Gulf Co-operation Council (GCC) and the GCC Customs Union (members – Bahrain, Kuwait, Oman, Qatar, Saudi Arabia and the UAE)¹⁴ which came into force in January 2015. The major elements of the union include a Common External Tariff (CET) and common model laws on customs and trade remedies. The respective customs administrations of GCC members retain their autonomy and there is no integration of their functions at present. There are still differences between the GCC members, but in spite of this there will be slow integration forward.

The nuclear deal with Iran will revive and promote trade between the UAE and Iran.

The UAE is also a member of the Pan-Arab Free Trade Area (PAFTA) that entered into force in 1998. It provides for the facilitation and development of inter-Arab trade in goods. A separate agreement on the trade in services is currently under negotiation

The UAE is deepening its ties with Asia, to boost trade and investment. China's importance in the UAE is expanding – a reflection of China's energy needs and the UAE's keenness to become less dependent on the West.

The UAE is also a member of the WTO.

8. AGRICULTURAL, FORESTRY AND FISHERIES PROFILE¹⁵

8.1 Production

The lack of arable land, intense heat, periodic locust swarms and limited water supplies are the major reasons why agriculture accounts for less than 1 % of the UAE's GDP. Most of the cultivated land is in the Emirate of Abu Dhabi.

Main agricultural products produced comprise of dates, tomatoes and fresh vegetables. The main livestock production is chickens, goats, camels and cattle.

8.2 Major imports from and exports to the world

It is estimated that the GCC import nearly 90% of their food and feed needs and that between 40 and 50 % of the UAE food imports is re-exported to Middle Eastern Countries, Africa and Asia¹⁶. The UAE is however a net food importer.

Table 6 and 7 indicates the top imports and exports of the UAE from/to the world. The average yearly imports of AFF products from the world amounted to R 126 billion between 2010 and 2014, while the average yearly exports of AFF products to the world was R 50 billion during the same period. Some of the major imports from the world by the UAE were cigarettes (HS 240220), rice (HS 100630), refined sugar (HS 170199), milk & cream power (HS 040221) and rape or colza seeds (HS 120510), while some of the major exports were refined sugar (HS 170199), rape or colza oil (HS 151411), black tea (HS 090230), milk & cream power (HS 040221) and cigarettes (HS 240220). A major percentage of the UAE trade is re-exports as can be seen in the tables. The UAE is the trade hub of the region.

It must be noted that the data used were mirror data as in the trade map database. Mirror data is where the reporting country don't supply data and the data came from the country that imports or exports to the reporting country. Annex 2 and 3 give a more comprehensive list of the imports and exports of the UAE to the world.

A major percentage of the UAE trade is re-exports.

9. TRADE & TARIFF POLICIES¹⁷

The UAE has a relatively liberal trade regime, with an open trade policy. The foreign trade policy aims at promoting trade relations and to increase the contribution of foreign trade as percentage of the GDP. With multilateral trade liberalization and bilateral and regional agreements the UAE tries to get improved market access for its products.

In January 2015 the GCC Customs Union came into force. There is no custom tariffs payable for goods manufactured and transported to another GCC member state. Non GCC Customs Union members trade on a MFN basis with the UAE and pay the common external tariff except where a bilateral trade agreement provide preferential access into the UAE.

Table 9 indicates the tariffs charged by the UAE. It is noted that bevarages & tobacco are the only product group with an average MFN applied tariff of more than 5%.

10. AGRICULTURAL, FORESTRY AND FISHERIES TRADE STRUCTURE AND PRODUCT ANALYSIS BETWEEN SA AND THE UAE

The 1st Joint Commission between SA and the UAE was held at the end of August 2015. During this meeting, an agriculture and food security subcommittee was established. The Joint Committee has suggested that a Joint Business Council must be established and that there must be a person in the council that represents the agro business sectors interest.¹⁹

Table 10 below indicate the top imports of AFF products by SA from the UAE. Total average imports per year between 2010 and 2014 were R140 million. Annex 4 provides a more detailed list of the import of AFF products by SA from the UAE.

Table 11 indicates an increasing trend for the exports of AFF products by SA tot the UAE. The average yearly exports between 2010 and 2014 were R1.96 billion. The top products based on average yearly exports were fresh fruit, ethylmol and wine. Annex 5 provides a more detailed list of exports of AFF products by SA to the UAE.

11. AGRICULTURAL MARKETS ACCESSIBILITY²⁰

The UAE is a trading nation with a relatively open economy. As mentioned earlier re-exports is important in the UAE (between 40 and 50 % of the UAE food imports is re-exported). The UAE is highly competitive because of the following: low administrative import and export cost, the ease of customs procedures and well developed seaport and airport infrastructure and facilities.

“Food labels must include product and brand names, production and expiry dates, country of origin, name and address of the manufacturer, net weight in metric units, and a list of ingredients and additives in descending order of importance.”²¹

The publication “All you should know before exporting to UAE” <[agritrade.iift.ac.in/html/Training/Market study/UAEFinal_Report.pdf](http://agritrade.iift.ac.in/html/Training/Market%20study/UAEFinal_Report.pdf)> give a more detailed description of the requirements to export to the UAE.

12. TRADE POTENTIAL ANALYSIS

The trade potential analysis is done via the trade potential index (TPI) and the "trade chilling concept". The TPI concentrates on products that are already traded between countries (trade deepening), while "trade chilling" concentrates on products that are not currently traded between countries, but have the potential to be traded (trade widening). Point 12.1 discusses the TPI and point 12.2 the "trade chilling concept".

It is important to understand the TPI and the "trade chilling" concepts. Note that they only indicate what products can be exported under certain criteria as described in the methods used. For example, if it is indicated that SA can export a product to the other country, but SA doesn't export the product because of phyto-sanitary reasons that prohibit the import of the product by the other country from SA and it must be taken into consideration.

12.1 Trade potential index (TPI)²²

The Trade Potential Index uses a scoring system based on data obtained from the Trade Map database to determine which products have the potential to be exported to a country. The trade indicators contained in the database used were: Did SA export to the UAE; is the exports by SA to the UAE growing; is the UAE imports from the world growing; is SA exports to the world growing; and is the average indicative trade potential (ITP)²³ larger than R 1 million. The TPI concentrates on products that are already traded between countries (trade deepening). The TPI is measured against a potential score of 5. A score of 0 would represent the lowest end of the scale and the least trade potential whilst a score of 5 would indicate the greatest trade potential.

Table 13 indicate the top 15 products identified for potential exports according to the TPI. The top five products for potential exports are: food preparations (HS 210690), refined sugar (HS 170199), fresh apples (HS 080810), maize (HS 100590) and wines (HS 220421). It is important to note that only the top products (with the highest ITP for potential exports) are indicated in table 13. There are much more products for potential exports, if one looks at the TPI list in annex 7.

Annex 6 gives a more comprehensive description of the TPI.

12.2 "Trade chilling concept"

The Trade chilling concept is a method used to indicate which products have the highest potential to be traded between countries if current trade flows are excluded (There is no trade in the products between the countries). Because current trade flows are excluded, this refers to trade widening, rather than to trade deepening as in the TPI.

The trade chilling concept refers to products which the UAE and South Africa are trading with the rest of the world, but not with each other. The trade chilling took the following into consideration: (i) where the average annual product trade between the UAE and South Africa were R10 000 or less between 2010 and 2014, no trade is assumed (ii) global annual average imports into the UAE between 2010 and 2014 (iii) the annual average global product exports by SA Between 2010 and 2014. The ITP is also indicated in the table, to give an indication of the additional potential trade between the two countries.

Table 14 indicate the top 15 products for potential exports to the UAE according to the trade chilling concept. If the average annual trade between SA and the UAE was R10 000 or less, it was assumed that no trade has taken place. The top products identified here are: doors and their frames (HS 441820), milkpower (HS 040210), cartons, boxes and cases (HS 481920), soya bean-oilcake (HS 230400) and paper (HS 480411).

The complete trade chilling table is in annex 8. **It is important to not only look at the table with limited tariff lines, but rather to look at the annex that shows trade chilling in more detail.**

13. CONCLUSION

The objective of understanding the UAE environment, with a focus on trade was discussed under the following points: country facts of the UAE, historical background and economic overview, infrastructure of the country, the UAE risk profile and trade agreements. This was followed by a discussion of the agricultural, forestry and fisheries profile, trade and tariff policies, trade structure & product analysis, and market accessibility.

The primary objective of the study was to identify which products may have the potential to be exported by SA to the UAE. The following were used to identify potential exports: a & b) Current trade (with the world and with SA), c & d) the Trade Potential Index and Trade Chilling.

The top five agricultural/forestry/fisheries products identified according to the techniques mentioned are:

- The UAE imports from the world – cigarettes (HS 240220), rice (HS 100630), refined sugar (HS 170199), milk & cream power (HS 040221) and rape or colza seeds (HS 120510)
- SA exports to the UAE: Oranges (HS 080510), Lemons and Limes (HS 080550), Grapes (HS 080610), Apples (HS 080810) and Ethyl Alcohol (HS 220720)
- Products with an export potential according to the TPI: food preparations (HS 210690), refined sugar (HS 170199), fresh apples (HS 080810), maize (HS 100590) and wines (HS 220421)
- Products with an export potential according to trade chilling: doors and their frames (HS 441820), milkpower (HS 040210), cartons, boxes and cases (HS 481920), soya bean-oilcake (HS 230400) and paper (HS 480411).

Although these products are identified for potential exports, **it is important to note that there are many more products that could be identified** (these products here have been identified for summary purposes). The techniques used should be considered and then identify if the tariff line of the relevant product is included in the tables or annexes. From this one will be able to identify which products may have the potential to be exported to the UAE.

The UAE is a net food importer and between 40 and 50 % of the UAE food imports are re-exported to Middle Eastern Countries, Africa and Asia. The lifting of sanctions against Iran, may contribute to an increase in the quantity of products re-exported by the UAE. As the GCC import nearly 90% of their food and feed needs²⁹ and the UAE is a re-exporter to these countries, the UAE is seen as 'n country to which exports can increase.

ANNEXES

Annex 1: Definitions of different types of risk³⁰

Definitions:

Sovereign risk

This risk category assesses the risk that the sovereign or an entity guaranteed by the sovereign defaults on its debts. Sovereign default is defined as a build-up in arrears of principal and/or interest on foreign- and/or local-currency debt owed by a government or a government-guaranteed entity. The sovereign risk rating is informed by scores for a combination of political, policy, cyclical and structural variables.

Currency risk

This risk category measures the risk of a devaluation against the reference currency (usually the US dollar, occasionally the euro) of 25% or more in nominal terms over the next 12-month period. The currency risk rating is informed by scores for a combination of political, policy, cyclical and structural variables.

Banking sector risk

This risk category gauges the risk of a systemic crisis whereby bank(s) holding 10% or more of total bank assets become insolvent and unable to discharge their obligations to depositors and/or creditors. A banking crisis is deemed to occur even if governments restore solvency through large bail-outs and/or nationalisation. A run on banks facing a temporary lack of liquidity rather than underlying solvency problems is not deemed to constitute a crisis, provided that public confidence in the banking system is quickly restored. Banking crises are typically associated with payment difficulties in the corporate or household sectors; bursting of asset price bubbles; currency and/or maturity mismatches. The rating can therefore serve as a proxy for the risk of a systemic crisis in the private sector. The banking sector risk rating is informed by scores for a combination of political, policy, cyclical and structural variables.

Political risk

This risk category evaluates a range of political factors relating to political stability and effectiveness that could affect a country's ability and/or commitment to service its debt obligations and/or cause turbulence in the foreign exchange market. The political risk rating informs the ratings for sovereign risk, currency risk and banking sector risk.

Economic structure risk

This risk category is derived from a series of macroeconomic variables of a structural rather than a cyclical nature. Consequently, the rating for economic structure risk will tend to be relatively stable, evolving in line with structural changes in the economy. The economic structure risk rating informs the ratings for sovereign risk, currency risk and banking sector risk.

Overall country risk

This risk rating is derived by taking a simple average of the scores for sovereign risk, currency risk and banking sector risk.

It is important to note what criteria are used. The products identified for potential exports are based on the criteria used.

The Trade Potential Index uses a scoring system based on data obtained from the Trade Map database. This allows the analysis to focus on trade potential whilst taking cognizance of import demand, import trends, growth rates and unit values rather than focusing solely on trade potential values. A score of either 1 or 0 is assigned to the five trade indicators contained in the database. This score is then aggregated to give a total score, which is measured against a final score of 5. A score of 0 would therefore represent the lowest end of the scale and the least trade potential whilst a score of 5 would indicate the greatest trade potential.

The criteria for scoring are as follows:

- The value of imports from a country: If trade in the form of average exports by SA to the UAE did exist between 2009 and 2014, and the average value was more than R10 000 a year, a score of 1 is allocated. The absence of trade (or trade less than R10 000) is allocated a score of 0. The existence of a trade relationship is deemed a significant factor in furthering trade.
- Growth in export demand: If the exports from SA to the UAE have registered a positive growth measured over the five year period from 2009 to 2013, a score of 1 is allocated. No growth or negative growth rates are awarded a score of 0.
- Growth in import demand: If imports by the UAE from the rest of the world have registered a positive growth measured over the period from 2010 to 2014, a score of 1 is allocated. No growth or negative growth rates are awarded a score of 0.
- Export growth: Growth of exports from SA to the rest of the world is indicative of supply capacity, and increased demand for locally produced goods. A positive growth rate in the value of exports over a five year period from 2010 to 2014 is awarded a score of 1, whilst no or negative growth is awarded a score of 0.
- Indicative Trade Potential: Indicative trade potential isolates total demand and total export capacity thereby providing a rough estimate of how much countries could 'theoretically' trade between them. A positive 'indicative trade potential' suggests that a trade opportunity exists. A threshold value of an average amount of R1 million for the period between 2010 and 2014, is set for the allocation of a score of 1. Trade potential with a lower value or with no or negative trade potential values are allocated a score of 0
