SOUTH AFRICA POULTRY (HS0207¹) TRADE

1. Purpose

The document focuses on South Africa (SA)'s overall poultry trade with the World and overall chicken trade with the USA for a selected period. It starts by highlighting SA's poultry production and consumption to determine the state of self-sufficiency.

2. SA Poultry Production and Consumption: 2000/01 to 2017/18

For the period 2000/01 to 2017/18, SA poultry production was lower than the country's consumption, table 1. On average during the stated period, SA could only produce 85% of the required quantity of poultry. For the past five years from 2013/14 to 2017/18 (Table 1), the self-sufficiency ratio has been constantly declining. Indications are that, SA is reliant on poultry meat imports to satisfy the demand in the country.

3. SA Total Poultry Imports and Exports

On average from 2013 to 2018, SA poultry exports to the World was only 13% of SA's poultry imports from the World, figure 1. The graph below also reflects that for the period 2013 to 2018:

- SA Poultry Imports from the World:
 - On average, grew by 8% from 390 000 tons in 2013 to 564 000 tons in 2018;
 - $\circ~$ Yielded the highest growth of 22% in 2015 from 393 000 tons in 2014 to 478 000 tons in 2015;
- SA Poultry Exports to the World:
 - \circ Grew on average by 0.22% from 55 000 tons in 2013 to 52 000 tons in 2018;
 - Grew the highest from 2013 to 2014, at 25% from 55 000 tons to 69 000 tons, respectively;

3.1. SA poultry exports performance by destination: 2016 to 2018

Figure 2 below shows SA's poultry exports performance for the period 2016 to 2018.

The figure shows that SA poultry exports⁴ were absorbed mainly by Southern African countries. The top 8 SA poultry exports destinations (depicted in figure 2), dominated SA exports to the World by absorbing 96% of total SA poultry exports to the World. The performance of SA poultry exports were:

- Lesotho (29%), Mozambique (25%) and Namibia (18%) were the top 3 SA poultry exports destinations.
- On average from 2016 to 2018, the top 5 (i.e. Lesotho, Mozambique, Namibia, Zimbabwe, and Zambia) absorbed 86% of the total SA poultry exports to the World.
- For the period 2017 to 2018, Lesotho had the highest growth rate at 10% as SA's poultry exports destination in the World, despite the total SA poultry exports to the World declining by 22% for the period 2017 to 2018.
- Zimbabwe, ranked the 4th largest destination for SA poultry exports in the World on average, had the largest decline of 75% (i.e. from 4 900 tons in 2017 to 1 230 tons in 2018).
- Botswana, ranked on average the 6th largest SA poultry destination for the period 2016 to 2018, experienced the lowest decline of 4% in quantity (i.e. from 3 300 tons in 2017 to 3 100 tons in 2018).

3.2. SA poultry imports performance by Origin

Figure 3 below shows performance of SA's total poultry imports from the World from 2016 to 2018. The figure shows that, during this period:

- SA poultry imports predominantly emanates from Brazil, which supplied on average, 55% of all SA poultry imports;
- Despite experiencing the highest decline in growth of 72% in 2016/17 (i.e. from and 56% in 2017/18, Spain remained in the top 3 SA poultry supplier;
- The USA yielded the highest average annual growth rate of 115% (i.e. from 27 000 tons in 2016 to 91 000 tons in 2018);
- The USA grew by 226% (from 27 000 tons in 2016 to 87 000 tons in 2017),
- Argentina, the fourth largest SA poultry supplier in 2016 (19 000 tons); grew by 75% to be the third largest SA poultry supplier in 2017 (33 000 tons).
- The figure shows that on average from 2016 to 2018, the three largest SA poultry suppliers (i.e. Brazil 55%; USA 12%; and Argentina 5%), contributed a combined average of 72% of SA poultry imports from the World.

4. SA Poultry⁵ Products Trade Performance at HS6 Level

4.1. SA poultry products Imports performance

On average from 2016 to 2018, chicken (HS: 0207.1), dominated SA imports of poultry products from the World, contributing 95% of the total SA poultry to the World, whilst, Turkey (5%), ducks and geese (0%), were the other products in this category.

Table 2, below shows that on average from 2016 to 2018:

- HS020714- Chicken cuts and edible offal (including livers), frozen at 57%; and HS020712 - meat & offal of chickens, not cut in pieces, frozen at 37% dominated SA's poultry imports from the World;
- **HS020714** yielded the highest growth in this sub-sector at 10% from 302 tons in 2016 to 360 tons in 2018.
- SA imports of Ducks and Geese were negligible.

4.1.1 SA imports of bone-in-chicken pieces (0207.14.9)

Table 3 below shows the SA's imports of HS 0207.14 from the World. The table shows that on average from:

Bone in chicken pieces (0207.14.9) contributed 79% of the total HS 0207.14
 chicken cuts and edible offal imports from World;

• 0207.14.93 leg quarters, dominated SA's imports of chicken cuts and edible offal (0207.14) at 56% of the total SA imports of (0207.14) from the World.

4.2. SA poultry products exports performance

On average from 2016 to 2018, chicken **(HS: 0207.1)**, dominated SA exports of poultry products contributing 96% (i.e. 62 200 tons) of the total (i.e. 64 800 tons) SA poultry exports to the World (Table 6). The contribution of SA turkey **(HS0207.2)**, ducks **(HS0207.4)**, and geese **(HS0207.5)** to SA poultry exports to the World was negligible.

Table 4 shows that on average from 2016 to 2018:

- HS020712 meat & offal of chickens (39%); HS020714- chicken cuts and edible offal (34%); and HS020713 – chickens cuts (22%), contributed 95% to SA's total poultry products exports to the World;
- **HS020713** yielded the highest growth in this sub-sector at 14% (i.e. 11 600 tons in 2016 to 14 600 in 2018) to SA total exports of this sub-

sector to the World; whilst **HS020712** had the highest decline of 32% (i.e. 34 000 tons in 2016 to 16 000 tons in 2018).

5. SA-USA Chicken (0207.1) Products Trade

Table 5 below shows that for the period 2013 to 2018, SA poultry exports to the USA was 0.02% of the total SA poultry imports from the USA.

The table shows that:

- SA imports of poultry (HS0207) from the USA declined the highest, by 93% during the 2014/15 year from 5020 tons in 2014 to 331 tons in 2015;
- SA imports of poultry from the USA grew the highest during 2015/16 year by 8000% (i.e. 331 tons in 2015 to 27 000 tons in 2016); followed by another huge growth of 226% (27 000 tons in 2016 to 87 000 tons in 2017).

5.1. SA top Chicken (HS0207.1) Products Imports from USA

Table 6 below shows the average performance of SA's Chicken (0207.1) imports from the USA for the period 2016 to 2018.

The table shows that on average from 2016 to 2018:

- HS020714 chicken cuts and edible offal (including livers), frozen, contributed 99.8% of the total SA chicken (HS0207.1) imports from the USA; whilst HS020712
 meat & offal of chickens not cut in pieces, frozen contributed 0.2%;
- Bone-in chicken pieces 02071493-Leg Quarters (69%); 020714.98-Drumsticks (19%), 020714.97-Thighs (3%) and 020714.95-Wings (2%) had a combined share of 93% of the total SA chicken imports from the USA;
- The imports from the U.S. occurred despite the general duty of 37% levied on bonein chicken pieces and a further R9.40c/kg anti-dumping duty charged on imports from the U.S. above the 65 000 tons per annum agreed upon in the 2015 AGOA deal;
- **HS02071411 Breasts**, was the largest growing SA chicken imports sub-sector from the USA with 85% (i.e. from 1971 tons in 2017 to 3655 tons in 2018).
- **02071429 other offal** was the highest declining SA chicken import sub-sector from the USA with -52%, from 1510 tons in 2017 to 721 tons in 2018.

5.2. USA Competitors in SA Chicken (HS0207.1) Imports

Table 7 below shows that on average from 2016 to 2018, Brazil was the dominant SA chicken supplier in the World. The table shows that:

- Brazil was the main supplier of the following SA chicken products imports:
- 02071493-leg quarters (35%);
- 02071411–breasts (74%);
- 02071495-wings (14%);
- 02071429–other offal (52%); and
- 02071210-mechanically deboned meat (92%)
- The USA dominated the supply of:
- 02071498-drumsticks (40%); and 02071497-thighs (24%);

6. Conclusion

The article shows that SA is not self-sufficient in terms of poultry production, as consumption exceeds local production. It is for this reason that SA, in order to satisfy the demand, has been a net importer of poultry from as far back as year 2000 and continues to be to the present. It is also evident from the report that SA imports mainly chicken, and not ducks/ geese/ turkeys and guineas from the World under HS 0207.

SA's imports of bone-in meat chicken portions (HS0207.14.9), dominated SA total chicken imports from the World during the period from 2016 to 2018 and it is highly likely that the same pattern prevailed during the other years. The figures above also show that Brazil and USA were the major suppliers of SA poultry imports with a combined share of 67% of the total SA poultry imports from the World.

The destination of South Africa's poultry exports was mainly to Southern African countries who absorbed 96% of total SA poultry exports to the World.
