Bidders shall be registered with the Construction Industry Development Board (CIDB) and should have a minimum CIDB Contractor grading of 4CE or higher.

Only tenderers who meet the following Pre-qualification criteria for Preferential Procurement may respond:

- An EME or QSE.

Bidders must attach either their B- BBEE Status Level Verification Certificates (Verification Agencies accredited by SANAS or Sworn Affidavit signed by the deponent and attested by the Commissioner of Oaths to substantiate their BBEE rating claims.)

NB: The department reserves the right to request bidders to submit their current Audited Financial Statement/s.

Note: Any tender not complying with the above-mentioned stipulation, will be regarded as non-responsive and will therefore not be considered for further evaluation.

Preferential Procurement Policy Framework Act (PPPFA), Act no. 5 of 2000 read together with Preferential Procurement Regulations of 2017 is applicable . The 80/20 Preference Point system will be applied where a maximum of Eighty (80) tender adjudication points will be awarded for PRICE and Twenty (20) points will be awarded for PREFERENCE.

Bids will also be evaluated on local content as indicated below.
