NOTES

The purpose of this document is to:

- (i) Draw special attention to certain general conditions applicable to government bids, contracts and orders; and
- (ii) To ensure that clients be familiar with regard to the rights and obligations of all parties involved in doing business with government.

In this document words in the singular also mean in the plural and vice versa and words in the masculine also mean in the feminine and neuter.

- The General Conditions of Contract will form part of all bid documents and may not be amended.

- Special Conditions of Contract (SCC) relevant to a specific bid, should be compiled separately for every bid (if applicable) and will supplement the General Conditions of Contract. Whenever there is a conflict, the provisions in the SCC shall prevail.

General Conditions of Contract

1. Definitions

1. The following terms shall be interpreted as indicated:
- 1.1 "Closing time" means the date and hour specified in the bidding documents for the receipt of bids.
- 1.2 "Contract" means the written agreement entered into between the purchaser and the supplier, as recorded in the contract form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein.
- 1.3 "Contract price" means the price payable to the supplier under the contract for the full and proper performance of his contractual obligations.
- 1.4 "Corrupt practice" means the offering, giving, receiving, or soliciting of any thing of value to influence the action of a public official in the procurement process or in contract execution.
- 1.5 "Countervailing duties" are imposed in cases where an enterprise abroad is subsidized by its government and encouraged to market its products internationally.
- 1.6 "Country of origin" means the place where the goods were mined, grown or produced or from which the services are supplied. Goods are produced when, through manufacturing, processing or substantial and major assembly of components, a commercially recognized new product results that is substantially different in basic characteristics or in purpose or utility from its components.
- 1.7 "Day" means calendar day.
- 1.8 "Delivery" means delivery in compliance of the conditions of the contract or order.
- 1.9 "Delivery ex stock" means immediate delivery directly from stock actually on hand.
- 1.10 "Delivery into consignees store or to his site" means delivered and unloaded in the specified store or depot or on the specified site in compliance with the conditions of the contract or order, the supplier bearing all risks and charges involved until the supplies are so delivered and a valid receipt is obtained.
- 1.11 "Dumping" occurs when a private enterprise abroad market its goods on own initiative in the RSA at lower prices than that of the country of origin and which have the potential to harm the local industries in the

- 1.12 "Force majeure" means an event beyond the control of the supplier and not involving the supplier's fault or negligence and not foreseeable. Such events may include, but is not restricted to, acts of the purchaser in its sovereign capacity, wars or revolutions, fires, floods, epidemics, quarantine restrictions and freight embargoes.
- 1.13 "Fraudulent practice" means a misrepresentation of facts in order to influence a procurement process or the execution of a contract to the detriment of any bidder, and includes collusive practice among bidders (prior to or after bid submission) designed to establish bid prices at artificial non-competitive levels and to deprive the bidder of the benefits of free and open competition.
- 1.14 "GCC" means the General Conditions of Contract.
- 1.15 "Goods" means all of the equipment, machinery, and/or other materials that the supplier is required to supply to the purchaser under the contract.
- 1.16 "Imported content" means that portion of the bidding price represented by the cost of components, parts or materials which have been or are still to be imported (whether by the supplier or his subcontractors) and which costs are inclusive of the costs abroad, plus freight and other direct importation costs such as landing costs, dock dues, import duty, sales duty or other similar tax or duty at the South African place of entry as well as transportation and handling charges to the factory in the Republic where the supplies covered by the bid will be manufactured.
- 1.17 "Local content" means that portion of the bidding price which is not included in the imported content provided that local manufacture does take place.
- 1.18 "Manufacture" means the production of products in a factory using labour, materials, components and machinery and includes other related value-adding activities.
- 1.19 "Order" means an official written order issued for the supply of goods or works or the rendering of a service.
- 1.20 "Project site," where applicable, means the place indicated in bidding documents.
- 1.21 "Purchaser" means the organization purchasing the goods.

- 21.1 Delivery of the goods and performance of services shall be made by the supplier in accordance with the time schedule prescribed by the purchaser in the contract.
- 21.2 If at any time during performance of the contract, the supplier or its subcontractor(s) should encounter conditions impeding timely delivery of the goods and performance of services, the supplier shall promptly notify the purchaser in writing of the fact of the delay, its likely duration and its cause(s). However, the supplier shall continue performance of the contract to the extent not terminated.

23.3 Where the purchaser terminates the contract in whole or in part, the purchaser may decide to impose a restriction penalty on the supplier by prohibiting such supplier from doing business with the public sector for a period not exceeding 10 years.

23.4 If a purchaser intends imposing a restriction on a supplier or any

person associated with the supplier, the supplier will be allowed a time period of not more than fourteen (14) days to provide reasons why the envisaged restriction should not be imposed. Should the supplier fail to respond within the stipulated fourteen (14) days the purchaser may regard the intended penalty as not objected against and may impose it on the supplier.

23.5 Any restriction imposed on any person by the Accounting Officer / Authority will, at the discretion of the Accounting Officer / Authority, also be applicable to any other enterprise or any partner, manager, director or other person who wholly or partly exercises or exercised or may exercise control over the enterprise of the first-mentioned person, and with which enterprise or person the first-mentioned person, is or was in the opinion of the Accounting Officer / Authority actively associated.

23.6 If a restriction is imposed, the purchaser must, within five (5) working days of such imposition, furnish the National Treasury, with the following information:

23.7 If a court of law convicts a person of an offence as contemplated in sections 12 or 13 of the Prevention and Combating of Corrupt Activities Act, No. 12 of 2004, the court may also rule that such person's name be endorsed on the Register for Tender Defaulters. When a person's name has been endorsed on the Register, the person will be prohibited from doing business with the public sector for a period not less than five years and not more than 10 years. The National Treasury is empowered to determine the period of restriction and each case will be dealt with on its own merits. According to section 32 of the Act the Register must be open to the public. The Register can be perused on the National Treasury website.

24. Anti-dumping and countervailing duties and rights

3.6. Develop a tool that will guide development and attract investment in the Municipality

Proposals are requested from suitably qualified and experienced service providers to develop a Spatial Development Framework in line with the Spatial Planning and Land Use Management Act, 2013 (Act No. 16 of 2013) and the DALRRD's Guidelines for the Development of Provincial, Regional and Municipal Spatial Development Frameworks and Precinct Plans 2017.

4. LEGISLATIVE CONTEXT

4.1. With the enactment of the Spatial Planning and Land Use Management Act (SPLUMA) in 2013, a new planning regime was introduced in South Africa. It replaced disparate apartheid era laws with a coherent legislative system designed to spatially transform the country in its democratic era.

4.2. Chapter 4 of the Spatial Planning and Land Use Management (SPLUMA) Act No 16 of 2013 requires National, Provincial and Local Municipalities to prepare Spatial Development Frameworks (SDFs).

4.3. The National Development Plan sets the country's strategic direction, Chapter 5 of the NDP focuses on environmental sustainability and resilience through an equitable transition to a low-carbon economy, which will also have implications on the way the spatial planning and development in South Africa is approached. Chapter 6 sets out specific targets and goals towards establishing a more inclusive rural economy through integrated rural development and Chapter 8, which focuses on the country's spatial planning system, requires that:

4.3.1. All municipal and provincial SDFs are translated into 'spatial contracts that are binding across national, provincial and local governments;

4.3.2. The current planning system should 'actively support the development of plans that cross municipal and even provincial boundaries', especially to deal with biodiversity protection, climate-change adaptation, tourism and transportation; and

4.3.3. Every municipality should have an 'explicit spatial restructuring strategy' which must include the identification of 'priority precincts for spatial restructuring'.

4.4. To give spatial expression to the NDP the Department has prepared the National Spatial Development Framework.

4.5. Section 20 (1) of SPLUMA requires the Municipal Council of a municipality by notice in the Provincial Gazette to adopt a municipal spatial development framework for its municipality.

4.6. Section 20 (2) states that the municipal spatial development framework must be prepared as part of a municipality's integrated development plan in accordance with the provisions of the Municipal Systems Act.

4.7. Section 26 (d) of the Local Government: Municipal Systems Act, No. 32 of 2000 (MSA) stipulates that the council's development strategies which must be aligned with any national

or provincial sectoral plans and planning requirements binding on the municipality in terms of legislation;

4.8. Section 26 (e) of the Local Government: Municipal Systems Act, No. 32 of 2000 (MSA) stipulates that all Municipalities are required to compile Spatial Development Frameworks (SDFs) as a core component of their Integrated Development Plans (IDPs).

4.9. The former Department of Rural Development and Land Reform (DRDLR) now the Department of Agriculture Land Reform and Rural Development (DALRRD) developed a Spatial Development Framework guideline document dated 2017 to assist practitioners and the various spheres of government with the process of preparing a Spatial Development Frameworks.

5. PROBLEM STATEMENT

5.1. Many Municipalities in the past have developed SDFs, either in silos or supported (technically and/or financially) by National or Provincial government with differentiated approaches undertaken to develop the SDF this was further aggravated due to a lack of comprehensive guidelines for the development of SDFs. Some SDF documents have been detailed enough to inform decision making while others only provide a broader framework found to be difficult in effectively facilitating implementation of government programmes.

5.2. Various shortcomings have been depicted in most SDF documents the Department participates in the COGTA IDP assessments which involves the analysis of SDFs on an annual basis which revealed many shortcomings in terms of the requirements set out in SPLUMA and the MSA and are therefore non-compliant with the provisions of the applicable legislation.

5.3. The problem is compounded by the fact that capacity, both to plan and implement plans in municipalities remain a challenge. Therefore, the project provides an opportunity for the Department to assist the municipality with meeting the legislative requirements that govern the preparation of Spatial Development Frameworks and provide a plan to guide the spatial transformation of the Dr Beyers Naude Local Municipality.

6. STUDY AREA

6.1. Dr Beyers Naude Local Municipality, the third largest Local Municipality in the country, is well positioned as a portal to the mystical Karoo, in a region renowned for its pristine natural environment, rich heritage, diverse peoples and cultures. The vast area (28,653 km² in extent) includes the towns of Graaff-Reinet, Willowmore, Aberdeen, Jansenville, Steytlierville, Nieu-Bethesda, Klipplaat and Rietbron; plus a number of smaller settlements and surrounding farms. It boasts several very popular tourist attractions, beautiful landscapes and a healthy climate. The town of Graaff-Reinet, 4th oldest in South-Africa and referred to as the "Gem of the Karoo", is a hub of agri-tourism activity; it is the political and administrative seat of the Municipality and is the centre where the biggest concentration of the population lives and works.

6.2. The second largest town is Willowmore, also with a strong and vibrant tourism and agricultural sector. Willowmore should be viewed as a strategically situated centre for managing and co-ordinating service delivery and public participation in the southernmost part of the Municipal area.

7. CRITICAL MILESTONES

7.1. The following phases and deliverables as contained in the DALRRD's Guidelines for the Development of Provincial, Regional and Municipal Spatial Development Frameworks and Precinct Plans 2017 shall be achieved in the formulation of the proposed SDFs.

7.2. Details regarding relevant requirements for each phase and the deliverables are found in the DALRRD Guidelines for the Development of Provincial, Regional and Municipal Spatial Development Frameworks and Precinct Plans 2017. Service providers are expected to consult the guidelines whilst formulating the SDFs.

7.3. In order to deliver on the deliverables (as stated above) the SDF should be in the form of text, maps, graphics and photographs. A tabular format shall be used for the purpose of summarizing the information collected.

7.4. Submissions should be in the form of both hard and electronic versions (both PDF and editable versions).

7.5. Final report in digital format and a full colour hard copy, must also be supplemented by:

- Roll-up Banner X3
- Booklets x 50
- Posters x 10

7.6. Electronic documents/ reports per phase as per programme of action must be made available.

7.7. The service provider must submit a detailed breakdown of activities as per phase/ major component with clear timeframe per deliverable.

8. OUTCOMES AND DELIVERABLES

8.1. All spatial information collected should be submitted in GIS capable file format (shapefile, geodatabase, layer file, data package, mxd files) for use in a GIS. The shapfiles must have clear attribute information that differentiates the SDF construct and its purpose, for example a service node shapfile should have an attribute called "description" with the value "service node". Metadata for all spatial information should be provided as per the metadata standard ISO 19115 & SANS 1878. Ownership of all metadata, data and spatial information generated and collected from this assignment vests in DALRRD. DALRRD will become the custodian of all spatial information collected.

8.2. Over and above, the GIS data must further meet the following requirements:

- All maps should be in A4 size in the document;
- Maps must be numbered and listed in the page of contents;
- All the text in the maps and the legends must be legible;
- The same map template / layout must be used throughout the document for sake of consistency;
- All maps should have the basic map elements, namely; a title, north arrow, legend, scale bar;
- All the features on the map must be explained in the legend;
- Symboology and colours must adhere to basic cartographic principles, colour coding;
- All mapping must be developed at an appropriate scale;
- Maps in Microsoft Word must have the corresponding Map Document (MXD) ready to be accessed in ArcGIS.

8.3. The Service provider would be expected to submit a final consolidated report which consists of the following to supplement the deliverables:

- SDF textual document including all maps, tables and figures in both hardcopy (printed) and softcopy (electronic as MS word document) image files as (e.g. JPEG, windows Bitmap, GIF, etc.);
- A0 Final SDF Plan;
- a separate Executive Summary Document;
- a public participation report;
- Roll-up Banner X3;
- Booklet x 50; and
- Posters X10
- Required 'fit for purpose' maps.

NB: All GIS data to be submitted, must meet the requirements as stipulated in paragraph 8.2. at each stage/milestone of the project. The Municipality reserves the right not to approve any stage of the project if requirements relating to GIS data are not met.

9. SKILLS REQUIREMENTS

9.1 Companies with individuals with qualifications and extensive experience will be required as detailed in Table 1 below.

9.1.1 A project leader must be registered Town Planner

- 9.2 Proven experience and thorough understanding in the following is also required:
- a) Land use management policies and legislation;
 - b) Previous experience in the development of a Land Use Scheme and Spatial Development Framework;
 - c) Previous experience with policy and / or planning work at a municipal level;
 - d) Research, analytical writing and communication skills.
- 9.3 In the case of a consortium, a letter of commitment from company / everyone is required and must be submitted.

10. PROJECT PHASES, DURATION AND COST

- 10.1 It is expected that the project be completed in a period of 12 months effective from the date of appointment. The target dates for each milestone (as well as the associated deliverable) and the amount of financial compensation for the work done is scheduled under Table 2.
- 10.2 Timelines for the proposed SDF must strictly be adhered to. Financial penalties will be imposed for any delay or non-compliance with time and quality requirements.

- 10.3 An amount for the final draft is payable upon ratification by the Department as well as by the mayoral committee /Executive committee of the affected municipality.

- 10.4 5% retention will be paid once proof of approval of the SDF as part of the IDP by the Municipal Council is provided. Service provider may apply to the department for the retention fee payment in the event that the municipality's council is not functional in that council meetings are not taking place. A formal letter from the municipality that confirms this situation will have to be presented to the department by the service provider.

- 10.5 Monthly reports (per phase) will be forwarded by the service provider to the DALRRD Directorate Spatial Planning and Land Use Management Services in Eastern Cape and the nominated official within the relevant municipality. The service provider will be required to report via a written and electronic report.

11. MANDATORY REQUIREMENTS

NB: Failure to submit/attach proof of the following requirements with the proposal will disqualify the bidder's proposal.

- 11.1 Compliance with all Tax Clearance requirements: Attach Valid Tax Clearance Certificate OR Compliance Tax Status Pin OR Central Supplier Database Number OR Report, where consortium/joint ventures/ sub-contractor are involved, each party to the association must submit separate Tax Clearance requirements.
- 11.2 A resolution authorizing a particular person to sign the bid documents (Full completion and signing of LA 1.6 or resolution on company letter head).
- 11.3 Letter of agreement signed by all parties in the case of consortium or joint venture or sub-contractor involved must be provided.

TECHNICAL MANDATORY REQUIREMENTS

- 12.2 A profile of each employee/company to work on the project with clear references to similar and related work undertaken in the past with clear evidence where a person member participated in or managed certain projects in the past which bears relevance to the work at hand. Clear indication of actual roles and responsibilities must be presented with verifiable proof.

- 12.3 General methodology for undertaking work of this nature. The methodology should also indicate the project milestones that will be used to measure the project progress.
- 12.4 Certified copies of all certificates, references, professional registration and related certification for all members of the proposed team must be attached.
- 12.5 Evidential and documentary proof of professional qualification, registration and affiliation. For instance, if a team member claims to be a Town Planner, a copy of the registration with the South African Council for Planners (SACPLAN) is required.
- 12.6 Any other information relevant to the determination of the suitability of the interested bidder for this project should be listed.
- 12.7 The following technical information must be submitted with the bid proposal:
- a) Relevant professional experience of the team leader and core supporting experts;
 - b) Organizational, managerial and technical ability;
 - c) Full CV's of all proposed team members;
 - d) Minimum 3 contactable current and previous client references for 3 different clients;
 - e) Associations and Professional Affiliations of companies and individuals;
13. INFORMATION GATHERING
- 13.1 The selected service provider will be expected to make contact with all the relevant officials and units within all spheres of government and other stakeholders of government or any entity holding information relevant to the project to obtain relevant information that will be required for the project when a need arises.
- 13.2 Existing information, which is available within the DALRRD Branch: Spatial Planning and Land Use Management will be made available to the appointed service provider during the execution of the project.
- 13.3 In the case where a letter to confirm and motivate for requesting information from the different spheres of government or parastatals is required, the Department will provide the requested letter.

13.4. Notwithstanding anything written in these terms of reference, the responsibility for collecting information necessary for the successful execution of the project remains entirely with the service provider.

14. TERMS AND CONDITIONS OF THE BID

14.1. Awarding of the bid will be subject to the Service Provider's express acceptance of the DALRRD Supply Chain Management general contract conditions.

14.2. The successful service provider will be expected to enter into a service level agreement with the Department in respect of the deliverables of the project and will be signed upon appointment

14.3. Service providers may not be appointed for more than 2 projects from SPLUM EC, DALRRD at any moment in time to ensure availability of capacity to undertake the volume of work.

14.3.1. Service Providers will be informed about the outcome of the bid in writing after the bid has been finalised / adjudicated.

14.3.2. No material or information derived from the provision of the services under the contract may be used for any other purposes except for those of the DALRRD, except where duly authorised to do so in writing by the DALRRD.

14.3.3. The successful Service Provider agrees to keep all records and information of or related to the project confidential and not discloses such records or information to any third party without the prior written consent of DALRRD.

14.3.4. The short-listed service providers may be required to do a presentation in person to the department, at their own cost should it be deemed necessary to do so.

14.19. The successful Service Provider agrees to keep confidential all records and information related to the project and not disclose such records or information to any third party without the prior written consent of DALRRD.

15 REPORTING AND ACCOUNTABILITY

15.1. All team members must be available for the duration of the project and the service provider is not allowed to change the composition without prior consent of the department.

15.2. During the execution of the project, the service provider will be required to submit progress reports and attend meetings at intervals as it will be determined by the project team or steering committee managing the project.

15.3. All information captured and or used to generate the outputs of the project remains the property of DALRRD and must be handed over in its totality when the project is closed. DALRRD will retain copyright and all associated intellectual rights thereof. This document together with all agreements to be or reached during the course of the project become part of the contract. The information must be captured and provided in a digital format as agreed (in writing) between the service provider and DALRRD. This agreement must be reached and signed off together with the project plan before the project commences.
