### 4. POINTS AWARDED FOR SPECIFIC GOALS

4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:

  - (b) recover costs, losses or damages it has incurred or suffered as a result of that person's conduct;
  - (c) cancel the contract and claim any damages which it has suffered as a result of having to make less favourable arrangements due to such cancellation;

### SECTION A: SPECIFICATION FOR PRINTING TENDER DOCUMENTS

1. Copy, bind and deliver 300 tender documents to the department of Agriculture, Land Reform and Rural Development at 270 Jabu Ndlovu Street, Pietermaritzburg
2. Bind document with black spine tape
3. Document to consist of +-280 inner 80gsm pages (A4 Single sided with +- 3 pages that need to be A3 for diagrams & maps)
4. This service will be conducted on an "as per request basis" "not once off and your monthly invoice will be determined on actual copies delivered
5. Sample copy to be supplied – to be picked up from 270 Jabu Ndlovu Street, average single request is approximately 25-30 tender documents.
6. Preferred supplier to be Pietermaritzburg based.
7. Delivery to be within 2 working days from receiving an instruction/requisition with the working document from the department irrespective of loadshedding stages.
8. Duration of the contract will vary depending on how often requests are made per month up and till 300 tender documents completed.

  - Proof of existing valid lease for suitable printing copy machine
